Members were asked to agree or disagree with the statements submitted and to rate the judge on a scale of 1 to 5 with a rating of 1 indicating strong disagreement and 5 indicating strong agreement with the statement. Members were also asked to rate the performance and reputation of the judge on the following scale: 1=not qualified, 2=minimally qualified, 3 =qualified, 4=well qualified, 5=outstanding.
